

ENROLLMENT INSTRUCTIONS

Thank you for your interest in MedBlue RxSM and/or MedBlue RxSM Plus. Enclosed are all the forms you will need to enroll.

Please note:

- The Centers for Medicare & Medicaid Services (CMS) require that you are entitled to Medicare Part A and/or enrolled in Medicare Part B to enroll in this plan.
- You must also live in South Carolina.
- You may only enroll in one Medicare Prescription Drug Plan at a time.
- You may not be enrolled in a Medicare Advantage HMO or PPO Plan; you may be member of Medicare Private-Fee-For Service plan or enrolled in an 1876 Cost Plan.
- You may join a Medicare Prescription Drug Plan during certain times of the year.

If you believe that you qualify to enroll, please follow these steps:

1. Fill out the enclosed enrollment form.
2. In the “plan premium option” section, choose how you want to pay your premium.
3. Put your enrollment form in an envelope and mail it to:

Want us to draft your monthly premiums from your bank account?

1. Fill out the bank draft authorization form.
2. Attach a copy of a voided check.
3. Make sure you fill the form out completely. If you leave anything out, we cannot process it.
We will bill you each month for your premiums due.

Once we receive your enrollment form, we will process it and submit it to CMS for approval. If CMS approves your enrollment request, you will receive a confirmation letter from us. We will send you your benefits packet and your MedBlue Rx or MedBlue Rx Plus ID card in a separate letter.

If CMS decides you are not eligible now for MedBlue Rx or MedBlue Rx Plus, we will send you a letter that tells you why you cannot enroll at this time. We will reimburse you the amount of any monthly premium you sent us.
